GRAND LODGE REINSTATEMENT FEE (Constitutes Break in Service)

2026 Reinstatement Fee: Now until April 2027 = \$125.00 (Increases to \$175 beginning April 1, 2027)

A BROTHER IS ELIGIBLE TO REINSTATE IF HE HAS BEEN NON-FINANCIAL IN THE GRAND LODGE FOR 1+ YEARS

A BACKGROUND CHECK IS REQUIRED FOR MEMBERS WHO HAVE A BREAK IN SERVICE FOR 3+ YEARS

(BACKGROUND CHECK FEE = \$25.00)

\$70.00 FOR ALL DEMITTING MEMBERS INTO THE JURISDICTION FOR THE PURPOSE OF PURCHASING THE MOST WORSHIPFUL UNION GRAND LODGE OF FLORIDA BLUE LODGE SPECIAL. IF THE MEMBER DOES NOT NEED THE BLUE LODGE SPECIAL, NO FEE IS REQUIRED. NOTE: ANNUAL DUES ASSESSMENTS ARE DUE DURING THE ANNUAL RETURN CYCLE.

NOTE: ALL DEMITTED OR HEALED MEMBERS MUST BE IN COMPLIANCE WITH THE GRAND LODGE REGALIA POLICIES. SEE REGALIA STANDARDS ON THE MWUGL WEBSITE.

GRAND LODGE DUES ARE SEPERATE FROM ALL FEES LISTED ABOVE AND ARE TO BE PAID DURING THE ANNUAL RETURN CYCLE BY ALL REGULAR, REINSTATED, HEALED MEMBERS, AND MEMBERS WHO HAVE DEMITTED INTO THE JURISDICTION. ALL NEW MEMBERS WHO ARE RAISED, REINSTATED, DEMIT IN, OR ARE HEALED OVER ON OR BEFORE JANUARY 15, 2027, WILL BE SUBJECT TO GRAND LODGE DUES.
